Preamble

World Taekwondo is the world's governing body for the Olympic and Paralympic sport of Taekwondo. Para Taekwondo is referred to in this document as World Para Taekwondo.

Article 1	
Objective	

These regulations are to effectively administrate the Para Taekwondo Geup/Dan Promotion Examiners of World Taekwondo (hereinafter "WT Para Taekwondo Belt Promotion Examiners"), in accordance with Article 8.2C and 22.6 of the WT Statutes.

Article 2	
	Administration

Overall administration of the World Para Taekwondo Geup/Dan Promotion Examiners shall be managed by World Para Taekwondo in cooperation with the Global Membership System (GMS).

Article 3	
Certification	

World Para Taekwondo will grant certification to Para Taekwondo Geup/Dan Promotion Examiners who have successfully completed the Para Taekwondo Geup/Dan Promotion Examiners Certification Course and passed the World Para Taekwondo required tests conducted under the supervision of World Para Taekwondo course instructors.

Article 4

World Para Taekwondo Geup/Dan Promotion Examiners Certification Course

The World Para Taekwondo Geup/Poom/ Dan Promotion Examiners Certification Course shall be conducted by World Para Taekwondo. World Para Taekwondo may delegate the operation of the course to Continental Unions (CUs) or Member National Associations (MNAs).

World Para Taekwondo can conduct Para Taekwondo Geup/Poom/Dan Belt Promotion Examiners Certification Courses. CUs can apply for hosting Para Taekwondo Poom/Dan or Geup Belt Promotion Examiners Certification Courses. MNAs or WT recognized training centers can apply for hosting Para Taekwondo Geup Promotion Examiners Certification Courses. The written approval of WT is required for the hosting of any Para Taekwondo Geup/Dan Promotion Examiners Certification Course by CUs and/or MNAs.

World Para Taekwondo Promotion Examiners Certification Courses are divided into Geup and Poom/Dan level.

- 4.1 Qualification of applicant for Para Taekwondo Geup Belt Promotion Examiners Course
 - 4.1.1 Holder of active Global Official License (GOL);
 - 4.1.2 Applicant who has experience in coaching and/or teaching Taekwondo;
 - 4.1.3 Applicant aged 21 years or older;
 - 4.1.4 Applicant who has a command of the English language both in speaking and writing
 - 4.1.5 Holder of WT recognized 3rd Dan or above
- 4.2 Qualification of applicant for Para Taekwondo Poom/Dan Belt Promotion Examiners Course
 - 4.2.1 Holder of active Global Official License (GOL);
 - 4.2.2 Applicant holding Para Taekwondo Geup Belt Promotion Examiners Certification;
 - 4.2.3 Applicant who has conducted geup belt promotion of Para Taekwondo practitioners
 - 4.2.4 Holder of WT recognized 4th Dan or above

4.4 General Information

- 4.4.1 Lecturers: World Para Taekwondo will appoint qualified educators for the Course.
- 4.4.2 Registration Fee: Applicants shall pay the prescribed registration fee as set out in the Outline for the Para Taekwondo Belt Promotion Examiners Certification Course. The registration fee may be adjusted for each location based on the assessment of WT.
 - 4.4.2.1 The registration fee shall be exempted only once for those who re-apply for the course within one years after failing to pass the test at previous course.
- 4.4.3 Location of Courses shall be announced on the WT website as well as in the GMS. Outline shall be sent to all MNAs by e-mail.
- 4.4.4 Registration process: Applicants shall complete and submit the World Para Taekwondo - designated Application Form for the Course, complete with a Curriculum Vitae and an ID photo (passport size). The registration may be done through the GMS.
- 4.4.5 WT will not provide any financial support for the applicants of the Para Taekwondo Belt Promotion Examiners Certification Course, unless otherwise specified in the outline. Therefore, costs, such as airfares and accommodation, shall be borne by the participant.
- 4.4.6 Curriculum: The WT Para Taekwondo Committee shall develop and update the course curriculum. The curriculum may vary from Para Taekwondo Geup and Poom/Dan Belt Promotion Examiners courses but will include the following topics:
 - WT Rules and Administration
 - WT Para Taekwondo impairment types
 - Training persons with an impairment
 - Belt promotion test procedures
 - Belt promotion requirements (syllabus)
 - Safeguarding
 - Code of Ethics

- WT Anti-doping and Medical Code
- Practice
- Other subjects deemed necessary
- 4.4.7 Hour of Education: Minimum of 16 hours for Geup level, 24 hours for Poom/Dan level (the education time might include online education, where available)
- 4.4.8 Evaluation test: The applicant must score at least 70 points out of 100 points in order to pass the evaluation test and become certified.

4.4.8.1Geup Level:	Written test (70%), Practical Test (20%) and Interview (10%) in English
4.4.8.2 Poom/Dan Level:	Written test (80%) and Interview (20%) in English

Article 5			
	Activation		

- 5.1 Once an applicant has passed the Para Taekwondo Promotion Examiners Certification Course test and is certified as a World Para Taekwondo Promotion Examiner, no annual membership fee shall be required.
- 5.2 WT shall send certificates, membership card and information on regulations of Para Taekwondo Promotion Examiners within a month after certification as a World Para Taekwondo Promotion Examiner.

Article 6

Para Taekwondo Geup/Dan Promotion Examiners Levels

World Para Taekwondo Geup/Dan Promotion Examiners are classified into two Levels as follows:

- 6.1 "Geup Level" is granted to an application who has successfully passed the Geup Level Para Taekwondo Promotion Examiners Certification Course test. The holder of Geup Level Para Taekwondo Belt Promotion Examiners Certificate is eligible to conduct Para Taekwondo 10-1 Geup promotion tests at a national level.
- 6.2 "Poom/Dan Level" is granted to an applicant who has successfully passed the Poom/Dan Level Para Taekwondo Belt Promotion Examiners Certification Course test. The holder of Geup/Dan Para Taekwondo Promotion Examiners Certificate is eligible to conduct Para Taekwondo 10-1 Geup promotion tests as well as Para Taekwondo Poom/Dan promotion tests.

Certified Para Taekwondo Poom/Dan Promotion examiners can only grade applicants up to the level just below their own.

Ex) A 4th dan examiner can conduct promotion tests up to 3rd Dan.

Article 7 Para Taekwondo Promotion Examiners Refresher Course

- 7.1 World Para Taekwondo shall conduct a Para Taekwondo Promotion Examiners Refresher Course if it is deemed that there is a need to update the Promotion Examiners rules and/or programs.
- 7.2 All certified World Para Taekwondo Promotion Examiners are requested to attend a minimum of one Refresher Course within three (3) years of validation period to renew the certificate.
- 7.3 Registration Fee: Applicants shall pay the prescribed registration fee as set out in the Outline sent out prior to every World Para Taekwondo Promotion Examiners Refresher Course.
- 7.4 A graduation diploma will be given to World Para Taekwondo Promotion Examiners who have completed the Para Taekwondo Promotion Examiners Refresher Course.

Article 8	
	Validation and Revocation

- 8.1 The World Para Taekwondo Belt Promotion Examiners Certificate shall be valid for three(3) years after passing the Para Taekwondo Belt Promotion Examiners CertificationCourse.
- 8.2 A World Para Taekwondo Belt Promotion Examiners Certificate shall be automatically revoked if the World Para Taekwondo Promotion Examiner fails to participate in a refresher course within three (3) years from the first day of the validation.
- 8.3 The World Para Taekwondo Belt Promotion Examiner may restore his/her revoked certification by attending and passing the test of another World Para Taekwondo Promotion Examiner Certification Course. The registration fee is exempt only once if the World Para Taekwondo Promotion Examiner attends the course withing three (3) years from the revocation of the certificate.

Article 9	
	Duties

- 9.1 A certified World Para Taekwondo Promotion Examiner shall abide by all the rules and regulations of WT and the World Para Taekwondo Promotion Test Rules.
- 9.2 A certified World Para Taekwondo Promotion Examiner shall act with dignity and pride.
- 9.3 A certified World Para Taekwondo Promotion Examiner shall continuously update themselves with the latest Rules and Regulations as well as other related guiding principles and codes of WT.
- 9.4 A certified World Para Taekwondo Promotion Examiner shall be responsible for updating his/her contact information in the GMS system and shall be liable for the accuracy of the information.
- 9.5 A certified World Para Taekwondo Promotion Examiner shall be responsible for updating the GMS with results from Belt Promotion Tests conducted by the Para Taekwondo Belt Promotion Examiner.

Article 10	
Disciplinary Measures	

In case that any World Para Taekwondo Promotion Examiner has committed inappropriate behavior, World Para Taekwondo has the right to recommend disciplinary measures such as warning, rebuke, suspension or deprivation of the certification in accordance with the relevant rules of WT.

Article 11	
Effectuation	

11.1 These Regulations shall be in force as of May 12, 2020 following the enactment approval of the WT Council.
